DEFINITIONS

Unless otherwise specified, words in this form have the same meaning as defined in the Municipal Government Act, RSA 2000, c M-26.

“**corporation**” means a corporation incorporated or continued under the *Business Corporations Act*, RSA 2000, c B-9;

“**Councillor’s family**” means the Councillor’s:

- a) spouse, meaning the spouse of a married Councillor, except a spouse who is living separate and apart from the Councillor if the Councillor and spouse have separated pursuant to a written separation agreement or if their support obligations and family property have been dealt with by a court order;
- b) adult interdependent partner, meaning a person with whom the Councillor has
 - i) lived with in a relationship of interdependence for a continuous period of not less than three years, or of some permanence, if there is a child of the relationship by birth or adoption; or
 - ii) entered into an adult interdependent partner agreement;
- c) children, by birth or adoption;
- d) parents; and
- e) spouse’s or adult interdependent partner’s parents.

“**distributing corporation**” means a corporation that is a reporting issuer as defined in the *Securities Act*, RSA 2000, c S-4, or a corporation that is a reporting issuer or a substantially similar corporation under the laws of another jurisdiction in Canada.

ADDITIONAL INFORMATION

How will the information be used?

Per Bylaw 20901 Council Disclosures, the purpose of this disclosure is to require members of Council to disclose certain information to the municipality and the public. No later than the last business day of February each year, the City Manager must publish the information disclosed by all Councillors in accordance with section 4, except the names of the Councillors’ family and other personal information, on the City’s website.

How often will this information be collected?

No later than 4:30 p.m. on the last business day of January each year, every Councillor must file a statement of disclosure with the City Manager. The information will be collected once a year, for the period January 1 - December 31. The forms will be required to be completed and submitted by January 31 of the year subsequent to the period being examined. For example, for the period January 1, 2024 to December

31, 2024, the form must be completed and submitted by January 31, 2025. The City Manager may provide any of the information disclosed by Councillors in accordance with section 4, including the names of the Councillors' family and other personal information, to any employee of the City who requires the information.
