1. Call to Order and Land Acknowledgement

MOVED: That the meeting be adjourned.

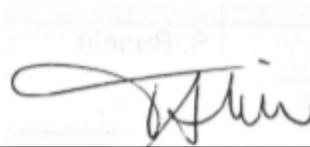
