

EDMONTON COMBATIVE SPORTS COMMISSION FINAL MEETING MINUTES

October 17, 2022 7:00 PM Online via Google Meet

1. Call to Order and Land Acknowledgement

The meeting was called to order by Chair, Trevor Kelly, at 7:06 pm., Monday, October 17, 2022.

It was acknowledged that the Edmonton Combative Sports Commission meets on the traditional territories of the indigenous peoples of the Treaty 6 region and the lands of the Métis represented by the Métis Nation of Alberta. The Chair acknowledged that we respect the histories, language and cultures of First Nations, Métis and Inuit, and all First Peoples of Canada whose presence continues to enrich our community.

It was suggested that Administration should look at licensing costs to see if they are comparable to other municipalities. This report will be used to inform the Commission if the policies/regulations are inclusive and complete.
