# **Contestant Licence Application Information Guide**

Edmonton Combative Sports Bylaw #15594 requires all contestants to hold both a valid **Annual Contestant Licence** and **Contestant Event Licence** to compete in ECSC sanctioned events. The Annual Licence is valid until the end of the calendar year and requires annual payment. The contestant Event Licence is only good for the date of the event. Contestants must pay for an Event Licence for each event they participate in while holding a valid and subsisting Annual Licence.

The following outlines key details for the both licence application processes:

### **Contestant Annual Licence Overview:**

- 1. Annual contestant Licence fee is \$25.00
- 2. One time payment. The annual licence is good until the end of calendar year
- An Annual Contestant Licence application form is provided on the City of Edmonton website (www.edmonton.ca) under Edmonton Sports Commission, 'forms'.
- 4. An Annual Contestant Licence is required in order for a contestant to be listed in "Good Standing" with the ECSC

#### **Contestant Annual Licence Application Requirements:**

- 1. Applicant's name, address and contact information
- 2. Gov't issued picture identification
- 3. Consent to the Executive Director obtaining any relevant information
- 4. Acknowledgement to abide by bylaw and ECSC rules and regulations
- 5. An Annual Licence does not in any respect suggest, indicate or specify an applicant's health status or medical fitness

#### **Contestant Event Licence Overview:**

- 1. Contestant Event Licence fee is **\$75.00**
- 2. Contestant event licence is only valid for the date of the event. A valid annual contestant licence is a prerequisite to obtain a contestant event licence.
- 3. Event licence fees can be paid by the event promoter
- 4. An Event Licence application can be completed the day of the weigh-in, if necessary.

#### **Contestant Event Licence Application Requirements:**

- 1. Applicant's name, address and contact information
- 2. Gov't issued picture identification

- 3. Inactivity information (if applicable)
- 4. Event type and Seconds' names
- 5. Promoter name
- 6. Declaration of good standing with their local Commission
- 7. Declaration that required information was forwarded to the Chief Medical Officer
- 8. Declaration of accurate fight and medical history
- 9. Declaration of any concussions or head injuries in the previous 60 days
- 10. Declaration of any injuries in the previous 60 days
- 11. Acknowledgement of the ECSC Rules and regulations

## **Combined Annual and Event Licence Application Form**

To expedite the licence application process, and for the benefit of non resident contestants, a combined licence application is also available for contestants. Informational requirements are the same as the Annual and per Event Licence. Combined Fee \$100.00.
