Coverage	Benefit Description
Eligibility	<ul style="list-style-type: none"> • Permanent full-time employees who are participating in the Group Life Insurance Plan, are under age 65, and are working at least 20 hours per week on a regular basis. • Must complete an application that includes a Health Questionnaire. • Insurer may request additional information (e.g. Doctor's report). • Insurer will review the application and any additional information and will approve or decline coverage.
Benefit Amount	<ul style="list-style-type: none"> • Available in multiples of \$25,000 to a maximum of \$250,000.
Premium Amount	<ul style="list-style-type: none"> • Depends on the age and gender of the employee as well as whether they are a smoker or non-smoker. • The member is responsible for the full amount of the premium through bi-weekly payroll deduction.
Effective Date of Coverage	<ul style="list-style-type: none"> • Effective on the 1st day of the month following the date the application is approved by the insurer.
Changes In Coverage Amount	<ul style="list-style-type: none"> • A change in the amount of optional insurance coverage is effective the 1st day of the month following the date of the change. • The member must be actively at work in order for the amount of insurance to increase. • The insurer may request additional medical evidence.
Termination of Coverage	<ul style="list-style-type: none"> • The earlier of: <ul style="list-style-type: none"> - day before the member attains age 65; - day on which the member no longer has Basic Life coverage; or - the date the member has asked, in writing, to have the optional insurance cancelled. - 31 days after termination of employment
Beneficiary	<ul style="list-style-type: none"> • May appoint one or more beneficiaries or change the appointed beneficiaries. • Designation of beneficiaries or a request to change beneficiaries must be in writing.

Coverage	Benefit Description
Waiver of Premium	<ul style="list-style-type: none"> • If a member becomes totally disabled prior to age 65 and remains disabled for a period of 6 consecutive months, coverage under the Optional Life Insurance Plan remains in force. • Member is not required to make premium payments until: <ul style="list-style-type: none"> - member ceases to be totally disabled, or - 3 months after the date that proof of total disability is requested and not received by the insurer, or - the member attains age 65, whichever occurs first.
Conversion Privilege	<ul style="list-style-type: none"> • A member who ceases to be insured prior to their 65th birthday may ask the insurer to issue a policy of individual life insurance without being required to submit evidence of insurability. • The former employee must submit a written application and first premium payment to the insurer within 31 days after coverage has terminated. • The individual policy must not be less than the minimum amount for which the insurer issues a policy and not more than the amount the member was insured for at the time they ceased to be insured, up to a maximum of \$200,000. • The maximum amount of insurance eligible for conversion will be reduced by the total amount of insurance in force, which was previously obtained under the terms of a Conversion Privilege included in this same policy.
Exclusions	<ul style="list-style-type: none"> • No benefit is payable if an individual commits suicide while sane or insane, within two years of the effective date of the coverage, or increased coverage.
