

CONTEST RULES

- 1. This contest runs from November 10, 2025, at 12:01 a.m. to December 5, 2025, at 11:59 p.m.
- 2. There is no charge or purchase required to enter the contest.
- 3. The chances of winning are dependent on the number of contest entrants.
- 4. One entry per survey participant is allowed. The contest is open to residents of the Edmonton metropolitan area who are 16 years of age or older.
- 5. The contest is not open to employees of the City of Edmonton.
- 6. Winners will be randomly drawn on Monday, December 11, 2025, at 10 a.m. MDT. Winners will be notified by email. Each entrant is eligible to receive a maximum of one prize.
- 7. In order to receive the prize, each contest winner must correctly answer a mathematical skill-testing question, and sign a contest release form confirming compliance with the contest rules and releasing the City of Edmonton, its parents, subsidiaries, affiliates, directors, officers, employees, insurers, and agents from any and all liability or any injuries, loss or damage of any kind arising from or in connection with this contest or prize won, including but not limited to any travel related thereto.

Return of any prize notification email as undeliverable or failure of the prize winner to respond to the prize notification and successfully answer the skill-testing question within ten (10) business days of notification of selection may result in disqualification and selection of an alternate winner.
