FORMAL PRESENTATION (Open to the public)

C.1 10729- 96 Street (DP) Ayman Almikdad-Mik-Tik Building & Design

Motion of non-support: N. LaMontagne

While the Committee supports this development in principle, there are a number of items that require significant review and refinement:

- The current building design is more residential in appearance (e.g. similar to the existing. houses south along 96 Street). Consider building facade modifications (e.g., increased glazing, window type/arrangement, door type/locations, glazed doors, signage style and locations, etc.) to provide a more commercial/storefront aesthetic that connects and contributes to the public realm and communicates its primary use. Use of fiber cement siding and brick would add durability and longevity over vinyl siding and reflect the larger context of the neighbourhood.
- Consider the addition of frontage/streetscape components (e.g.,landscape, site
 furniture, features, or surface patterning) to enhance the main floor building
 facade and concrete perimeter walk to foster a dynamic and engaging streetscape
 and a vibrant public realm, and an improved interaction between the built
 environment and the pedestrian experience.
- Consider an alternate location for moloks waste receptacles. While decorative, these moloks will be filled with garbage with the possibility of garbage overflow around the units and in the 107A Avenue frontage. Over time, these moloks may deteriorate and be less visually attractive.

The Committee also notes that this project would have greatly benefited from an informal presentation.
