- 4. Off-site Infrastructure Cost estimate form (high level cost estimates);
- 5. Conceptual Drawings, if available, that show potential service connections, utilities, infrastructure features, and any other information to assist with the review.

If your development project is at a pre-planning phase and you are not able to provide any of these items, please provide as much information about your project as possible where indicated throughout the form. The Infill Infrastructure Coordinator will utilize this information to make a decision on application eligibility and potential funding amount.
