## HERITAGE OUTREACH COMMITTEE REPORT Report to Edmonton Historical Board April 26, 2017

Items for Discussion or Information

1. Committee Reform - The Committee Terms of Reference have been amended to better reflect the work HOC is now doing (see attachment). We move that the EHB approve HOC's amended Terms of Reference.

2. EHB Rebranding - Graham Johnson of Curio Studio is looking into letterhead and business card design options for the EHB.

#### 3. EHB Promotion

1. Architectural Heritage Website - Tim and Sonia met with Ron Lameman, knowledge keeper of the Confederacy of Treaty Six First Nations, who will provide content for the Tepee section (modern and traditional styles, identifying current or past examples, permanent or temporary, of each), look at structures already profiled to add indigenous perspectives where appropriate (ex. City Hall was first designed to feature stylized tepees, rather than a pyramid), and make the Era write ups more inclusive. Tim and Sonia will also reach out to the Metis community for their perspectives and knowledge about built/landscape heritage. They will also work with the City's communications person to have these recent additions publicized more widely.

2. Value of Heritage Report next steps: (pre-brainstorming from HOC members) More research into ....

Include more Edmonton (and other) case studies that could provide a kind of "how to" to other builders and developers. Be specific about how the City helped, or could help more. Case studies should feel as if heritage developers were talking to other developers.

- Anton Morgulis' building at 109 Ave. and 119 St. (a more "modern" building in an area that isn't one of the usual heritage suspects. Beljan's stuff? Alhambra? Naryanni's?

- data for number of businesses that gravitate to heritage redevelopments, and how many are employed in the businesses. Collect hard dollar figures for Councillors and potential developers.

- strip malls (Newton area) that could be developed

- a competition for design/architecture students (NAIT, U of A, high schools) to reimagine some commercial properties on the Inventory. Be clear about heritage parameters (goes along with the idea of "how to" to encourage developers to invest in heritage for profit). Offer a prize! Publicize the contest! (Medicine Hat sponsored a design competition?)

## HERITAGE PLANNERS REPORT Report to Edmonton Historical Board April 26, 2017

Updates:

The reorganization of our Branch, City Planning, is nearing completion and will be effective as of mid-May. The Heritage Management Unit will be part of the Urban Design Team and will be reporting to General Supervisor, Peter Spearey. Our new Director will be Rhonda Toohey. Our Branch Manager remains Peter Ohm.

Westmount Community League has a committee focusing on the Westmount Architectural Historic Area (WAHA) that is advocating that the architectural guidelines be changed to regulations to ensure a higher level of integrity of the architectural styles within the WAHA. The committee applied to the City to amend the DC1 zoning. As this is a pilot project, it was agreed with the Westmount Community League that the rezoning fees will be paid from the Heritage Resources Reserve.

Brighton Block: Scott continues working closely with the new owner, Ken Cantor, and his architect to re-purpose the building for retail and offices.

Hangar 11: A Building Condition Assessment will be prepared by Integrated Infrastructure Services, using S2 Architecture and RJC Engineering. The Heritage Management Unit has also reviewed and accepted a Heritage Significance Assessment from David Murray Architect. Heritage is in discussions with the Blatchford Team to encourage them re-consider its plans for Hangar 11 to demolish it and instead explore preservation and adaptive re-use opportunities prior to selling it to NAIT. Outside of Hangar 14 (the Aviation Museum), Hangar 11 is the only remaining hangar on Blatchford Field.

Oliver 112 Street houses: The City has had a building condition assessment completed recently on the three properties, and have engaged Dub Architects to develop options to rehabilitate and re-purpose the buildings. At this point, there is not a specific re-use program that has been identified. David is working with the team for the assessments and reviewing the possibility of rezoning the site to allow for additions to be made at the rear of the buildings to provide additional redevelopment opportunity.

The Strathcona Walking Tour and Oliver Walking Tour booklets are now available. Applications for two separate grants have been submitted to Alberta Historic Resources Foundation (AHRF) to assist with printing costs. We should hear from ARHF by June.

The work of planWhyte continues. The goal is for a report to go forward to Urban Planning Committee in late May or early June for input and comments prior to a public Open House in June. The overall project intends to have draft recommendations by fall-2017. The objective is to reinforce the heritage character of the Provincial Historic Area, and identify redevelopment opportunities in the vicinity.

Church Street DC1 is nearing completion. It was presented to the Edmonton Design Committee and is expected to be heard by Council at Public Hearing sometime in June, 2017. The purpose of the DC1 zoning is to encourage the preservation of the areas unique collection of 12 culturally, historically and architecturally significant churches. This would apply to 96 Street between 106 Avenue and 110A Avenue.

David continues his role on the project team for the Rossdale Heritage Interpretative Plan, which will be developing a framework for how all aspects of the history of Rossdale can be celebrated. It will be a high level document, providing direction for the Business Plan and Interpretation Themes for the River Crossing project. The City is working with Form Media of Halifax on the project. The draft HIP is being finalized after a recent public open house on April 3.

*This Old Edmonton House* seminar series for 2017 is now close to wrapping up with the last course scheduled for May 2. Attendance has been the best in years. The class listings are online at ereg.edmonton.ca. David has worked diligently on reaching out to our targeted audience to ensure the success of the series. Come summer, it will be time to plan the for the 2018 seminar series.

Based on recent direction from Urban Planning Committee, David is working with the Zoning Bylaw Amendments team to formally enshrine documentation requirements for proposed demolitions of buildings on the Inventory. The City Council public hearing to adopt the amendments to the Zoning Bylaw will be June 28.

We applied for another Young Canada Works grant with National Trust Canada for 2017-18. We will hear the results of our application sometime mid-May 2017.

## HISTORIAN LAUREATE'S REPORT Report to Edmonton Historical Board April 26, 2017

Thanks to all of you for your patience with me through these busy months. I've been continuing to publish Let's Find Out, hosted a really fun live panel at the Needle Vinyl Tavern, and have been writing historical stories for CBC.ca.

1. Throughout February and March, CBC commissioned me to write a series of 10 articles for their Canada 2017 site, imagining what Canada would have been like without some influential Canadians like Elizabeth Bagshaw, Reginald Fessenden, and Rachel Zimmerman Brachman. My favourite story was about pioneering nuclear physicist Harriet Brooks:

2. In early March, CJSR hosted a radio camp for high school students from Kipohtakaw Education Centre in Alexander First Nation. We taught them how to use field recorders, conduct interviews, and edit their work. They hosted a live show on March 11.

3. I hosted a live panel talk at the Needle Vinyl Tavern on March 11, called Let's Find Out: How We Know What's True. Huge thank you to Sonia Caligiuri and the Edmonton Heritage Council for helping make that come together. We had a crowd of about 65 come out, and it aired on the podcast as well as on Shaw TV.

4. On March 25, I co-led a workshop on storytelling for the Next Up Edmonton leadership group.

5. On March 26, I spoke on a panel at Variant Edition about attracting listeners who don't already care about podcasts. It was hosted by Seen and Heard in Edmonton's Karen Unland:

6. On March 27, I was invited for a backstage tour of the Royal Alberta Museum, along with a few friends. The RAM's Kyla Tichkowsky and Amandah Van Merlin showed us some of the archaeological and paleontological collections, and introduced us to some staff whose work may overlap with my own in future.

7. On March 30, I moderated a panel on the Alberta media landscape for Public Interest Alberta's annual conference.

8. To mark the 100<sup>th</sup> anniversary of the Battle of Vimy Ridge, CBC commissioned me to write a story called, "When your first Canadian landlord is a Vimy veteran." I interviewed Edmonton's Peter Twiss for the story.

9. On April 10, Shawn Tse interviewed me at the City of Edmonton Archives for a video the Edmonton Heritage Council is showing off at their upcoming AGM.

10. On April 10, I visited the Bruce Peel Special Collections library at the University of Alberta, to see their new Mounties on the Cover exhibit.

11. At CJSR, I helped a group of Community Service Learning students from the University of Alberta create six radio documentaries. They covered topics like how teachers are using Indigenous music in classrooms, how the Rock en espanol movement was shaped by the Argentinian dictatorship, and how Colombians in Canada are affected by stereotypes about drugs and narcoculture. The docs will air April 19 and 26 from 11 AM – 1 PM on CJSR 88.5 FM.

Coming up:

-On May 1, I'll be presenting my annual report to City Council.

-I have applied to the Edmonton Heritage Council's Project Accelerator Grant fund to actually fund my own work on the podcast and hire an Assistant Producer from June 2017 – March 2018. This would allow me to increase the production quality of each episode and help with the research workload.

-The Edmonton Heritage Council has asked me to speak at their Canada 150-themed PechaKucha night.

-CityTV's Dinner Television has asked me to prepare some historical stories for Canada 150.

-On May 6, I'll be help MC and judge at the Edmonton Regional Heritage Fair.

-In late May, I'll be moderating a panel for the Asian Canadian Film Series at Metro Cinema.

-On June 9, I'll be speaking at the NEOS Miniconference at MacEwan University.

-In July, I'll be speaking at the Ignite Change conference.

## Naming Committee Report to Edmonton Historical Board April 26, 2017

1. Request to name an arterial roadway in the Riverview Area as "Richard Rice Boulevard"; Park within Stillwater as "Justina Rice Park"; Natural Area within Stillwater as "Alison Rick Natural Area"; and, a collector roadway within Stillwater as "Sunwapta Way"

On February 17, 2017, Administration received a naming application from Christopher Cairns (Sunwapta Developments) requesting to name four different items within the Stillwater Neighbourhood and Riverview Area. This application is requesting to name the future realigned 199 Street, south of 23 Avenue NW, located within the Riverview Area, as "*Richard Rice Boulevard NW*" in honour of Edmontonian of the Century Dr. Richard "Dick" Rice.

Additionally, requests were made to name a secondary park in the Stillwater neighbourhood as "Justina Rice Park" and to name the natural area-/wetland located within the Stillwater neighbourhood as "Alison Rice Nature Conservancy".

Carried unanimously.

#### 2. Request to name a park in Griesbach as "Maple Leaf Park"

Administration received a request from the Griesbach Community League to name a park "Maple Leaf Park". Carried.

#### 3. Request to rename a park in Griesbach as "Maple Leave Grove"

Per item 2, a park originally named "Maple Leaf Park," owned by Stantec representing Canada Lands, requires renaming. The larger, more prominent community park is now Maple Leaf Park. Stantec offered no concern for changing the name of the park, originally passed by the Naming Committee in 2007. Vote was deferred until recommendations for alternative names can be brought forward by administration.

#### 4. Request to name a roadway in the Glenwood Neighbourhood with an honorary name of "Gary Racich Way"

Administration received a naming application from Glenwood Community League requesting to apply the honourary name of "Gary Racich Way" onto 96 Avenue NW between 164 St NW and 165 St NW in the Glenwood Neighborhood. The application was supported with numerous community letters of support. Carried, unanimously.

#### 5. Discussion regarding the Names Sale Policy and Telus Field

The Naming Committee was apprised of the Names Sale Policy, and the request from Civic Events and Partnerships, Citizen Services, Community and Recreation Facilities seeking support for the sale of the naming rights of Telus Field (expired) to "Remax Field". Carried, unanimously.
