PLAQUES AND AWARDS COMMITTEE REPORT Report to Edmonton Historical Board August 23, 2017

In July the first draft of texts were edited by the P&A Committee and were submitted to the recipients for their first round of edits. As of the writing of this report, Neil and Kathryn are to meet on August 23rd to go over the second round of edits on the texts for the plaques and awards.

On July 25th, the P&A Committee held a meeting to discuss several matters.

1. Edmonton Salutes and the Art of Living

The first was the involvement of the EHB in the Edmonton Salutes awards, as recommended by the Art of Living. Kathryn shared the details of her meeting with the awards, generally, they agree with the board in that our awards do not match many of their own and that we should remain separate, however, as per the suggestion from the Art of Living, a potential way to get the EHB involved was discussed. It has been determined that some of the recipients of our Heritage Awards occasionally meet the qualifications of the heritage aspect of the Edmonton Salutes award. As such, it is recommended that from here onward, those recipients of the EHB award that meet said qualifications, should be nominated for an Edmonton Salutes award by the EHB in the year following their receival of an EHB award. This effort should bring the EHB closer to Edmonton Salutes, while also maintaining the mandates of both groups.

MOTION: That the P&A Committee begin nominating successful EHB award recipients for an Edmonton Salutes award if they meet the eligibility requirements.

2. The P&A Committee Award Ceremony

The second was the annual Award Ceremony held at the Prince of Wales. During this portion of the meeting, the feedback that the Board received from the last award ceremony was discussed. From this there were 3 areas that needed to be addressed.

- 1. Addresses in the Program
- 2. The Piper led procession in
- 3. The sound system

It was decided that addresses would be added to the profile pages of each Plaque and Award recipient. While these addresses were already in the pamphlet, they were not prominent so this should resolve this issue.

Secondly, the grand procession will now start in the Jefferson Room. At the start of the event, award and plaque recipients will be asked to wait in the Jefferson Room along with Board members. Then we shall proceed to march down the middle of the aisle and take our seats before the start of the ceremony. This should hopefully alleviate some issues in regards to organization prior to the start of the event.

Finally, it was decided that in 2018, a sound system would be rented to ensure that there is adequate sound throughout the Armoury, so that all guests can hear all parts of the ceremony.

Alongside these changes, some minor changes will be made to the pamphlet and invitation to incorporate the new logo of the EHB.

3. Ghost Sites and Nominations

Finally, members of the P&A Committee went over suggested changes to the EHB nomination process to be inclusive of 'Ghost Sites'. Specifically, changes were suggested for the eligibility requirements and necessary attachments that a successful application needs. Below are the original requirements, and then after are the highlighted suggestions for change.

Current Eligibility:

- Buildings, building fragments, and sites of any type including residential, industrial, commercial and public, and must typify cultural community, social or architectural development within the city.
- The owner(s) of the buildings, building fragments, and/or sites must provide written consent.
- In special circumstances, a plaque might be awarded for groups or figures that have made exemplary and outstanding contribution(s) to historical events that shaped the development of the City and are associated with a named feature (a park, building, etc..)

Current Attachments Required in Nominations:

- A description of the building/site's heritage value. Please include important occupants and the building/site's history. Description is not to exceed four typewritten pages.
- Supporting material (publications; news clippings, letters of support, photographs, etc..)

Suggested Eligibility Edits:

• Buildings and building fragments of any type including residential, industrial, commercial and public, and must typify cultural community, social or architectural development within the city.

• In special circumstances, a plaque might be awarded for groups or figures that have made exemplary and outstanding contribution(s) to historical events that shaped the development of the City and are associated with a named feature (a park, building, etc..)

 Historically significant sites that contain narratives that currently have no form of recognition in either name or plaque/marker in the area. These narratives must have historical significance to the history of the City of Edmonton and their narrative must be tied to a specific site, an original building or building fragment is not necessary for this type of nomination to be successful.

Demolitions:

To date eight (8) applications to demolish historic resources listed on the Inventory have been approved in 2017.

<u>Updates:</u>

Please join me in welcoming our new Graduate Heritage Planner, Deeksha Choudhry! She joined the Heritage Team on August 14, 2017. She is a graduate of University of Waterloo. During her co-op semester she worked on the River Crossing Historic Interpretative Plan.

Westmount Community League has a committee focusing on the Westmount Architectural Historic Area (WAHA) that is advocating for the development of new regulations to more effectively preserve the architectural character of the area. The committee applied to the City to amend the ARP and DC1 zoning. We have met with representatives of the committee and are scoping a process for proceeding with the initiative. The public launch of the project is targeted for November following the Municipal election.

A report on City Owned Historic Resource Management Strategy is being prepared for Urban Planning Committee for later this year with a recommended approach to ensure a development of a comprehensive strategy for the proper preservation of the City's existing historic resources. It will also establish direction on how the City maintains, programs, acquires and markets its historic resource assets in the future.

Transit Hotel is now officially closed. It is a historic resource on the Inventory, but not designated. Robert is monitoring the hotel and working closely with the Fort Road Business Association. With the business association, we plan on scheduling a meeting with the owner to have a discussion about the opportunity to designate.

Hangar 11: a draft of a Building Condition Assessment has been received by Integrated Infrastructure Services, using S2 Architecture and RJC Engineering. The Heritage Management Unit has also reviewed and accepted a Heritage Significance Assessment from David Murray Architect. Heritage is in discussions with the Blatchford Team to encourage them re-consider its plans for Hangar 11 to demolish it and instead explore preservation and adaptive re-use opportunities. Outside of Hangar 14 (the Aviation Museum), Hangar 11 is the only remaining hangar on Blatchford Field.

Oliver 112 Street houses: The City has had a building condition assessment completed recently on the three properties, and have engaged Dub Architects to develop options to rehabilitate and re-purpose the buildings. At this point, there is not a specific re-use program that has been identified. David is working with the team for the assessments and reviewing the possibility of rezoning the site to allow for additions to be made at the rear of the buildings to provide additional redevelopment opportunity.

The work of plan Whyte continues. The goal of this study is to better understand how the area's heritage, character and livability be further strengthened while exploring opportunities for additional development over the next 20-25 years. The study will examine heritage, land use, urban design, transportation, and development opportunities (outside the core heritage commercial area), in order to develop a design vision for the long term evolution of Whyte Avenue. A third public open house was held on June 20, 2017, which was well attended. The purpose of the open house was to present the draft design concept and project direction for feedback. A final open house will be held in fall 2017 to present the final recommendations prior to City Council consideration targeted for early 2018.

Church Street DC1 rezoning was approved by City Council at Public Hearing on July 10, 2017. The new DC1 zoning is to encourage the preservation of the area's unique collection of 12 culturally, historically and architecturally significant churches. This applies to 96 Street between 106 Avenue and 110A Avenue. In addition to the DC1, the first phase of interpretation for Church Street has been installed, with each of the 12 churches on being recognized with a Plaque.

On July 11th, City Council approved the River Crossing Heritage Interpretative Plan (HIP). The HIP will now move into work planning for short-term implementation, which will consist of low-cost tactical interpretation and events that leverage partnerships and existing programs to celebrate the four interpretive themes in the HIP. David will continue to be involved on the project team for the River Crossing Heritage Interpretative Plan. The City has hired a Stantec as consultant for the redevelopment concept design. Ritchie School built in 1913 at 9750-74 Avenue, owned by the Conseil Scolaire Centre-Nord is under threat. The owners have drawn up conceptual plans to build a new school, demolish the existing school except for the gym. Councillor Nickel is aware of this. The Province is also aware and has expressed their interest in the school. Our Unit and Citizen Services (Open Space Planning and Design) have been in a meeting with the school board and expressed our concerns. A design coordination meeting was held in June by owner's architect, Stantec. New school will be built while the 1950's portion of the existing school will continue to operate. The Province informed us they are unlikely to intervene to save the school.

At the June 28, 2017 Public Hearing, City Council approved amendments to the zoning bylaw, to formally enshrine documentation requirements for proposed demolitions of buildings listed on the inventory.

David continues to work with Real Estate and Housing on the planned rehabilitation of the Edmonton Iron Works. The City is arranging hazmat assessment and remediation work, as well as general clean-up of the building interior. A site meeting with Alberta Culture and Tourism was recently held to determine what portions of the building must be retained.

The Real Estate and Housing Branch has advertised Street Railway Substation No. 600, a MHR located on 124 Street, for sale. Potential purchasers will be required to submit proposals for the redevelopment and repurposing of the building. Scott will be included on a committee which evaluates the proposals to identify the successful purchaser.

Scott has joined the steering committee for the Coliseum Station Area Redevelopment Plan. The project area includes the Northlands exhibition grounds. Through the plan, the City will be seeking to establish a permanent location for the Old Timer's Roost, a vernacular log cabin constructed in 1928, so that it can be designated as a MHR. The plan will also identify opportunities to recognize the more than 100-year history of Northlands as the site of Edmonton's annual agricultural exhibition.

Scott has joined the Evolving Infill Working Group. The working group will support Evolving Infill 2.0, an initiative to mature the City's strategy related to residential infill. Best practices for preserving neighborhood character while accommodating infill, is one of the items to be addressed through the initiative.

CITY ARCHIVIST'S REPORT Report to Edmonton Historical Board August 23, 1017

The Archives is continuing to see high numbers of researchers this summer as well as groups of City Staff who are taking advantage of slower workloads to learn more about the Archives. We have had several tours of staff from the 311 Call Centre, Office of the City Clerk and Community Services.

Our last summer contractor has left to return to school. Dylan processed over 85 metres of records since the spring, including the Federation of Community League files and several collections from the Government Records. New and updated finding aids for several Municipal Departments have been completed and entered not only on our <u>http://archivesphotos.edmonton.ca</u> database but also on "Alberta on Record" a province wide archives network. We know that researchers have already found those new descriptions and are requesting the material in the Reference Room.

The Indigenous Peoples, First World War and the new Genealogical Sources research aids have been posted to the Archives webpage on edmonton.ca/archives. Hopefully, researchers will also find these subject focused tools helpful. Other subject guides will be developed by future practicum students in future.

The posting for the Archivist position (Tj's replacement) is now up on the City's Job website. Partly because of the loss of Tj as well as issues around space and access due to the upgrades on the facility's boilers and environmental control equipment we have called a temporary hiatus to the volunteer program until the new year 2018 when we will reassess it and it's goals. We say goodbye this month to our remaining four regular volunteers, Doug, Erica, Kevin and Len who together have put in thousands of hours assisting the archivists.

The Centennial Exhibit continues to travel around the City's recreation and attraction facilities. The Police 125 anniversary exhibit is also on the concourse until after Free Admission Day at the end of September.

HISTORIAN LAUREATE Report to Edmonton Historical Board August 23, 2017

- 1. I volunteered at the World Indigenous Nations Games on July 2 & 3, at Enoch Cree Nation.
- 2. I ran a series for the Edmonton's Historian Laureate Facebook page for five days leading up to Canada Day. Each day, I featured a different Edmontonian's ideas for ways to work through our complicated feelings about Canada 150 through some sort of homework or volunteering. Miranda Jimmy, Ahmed Knowmadic, Kathryn Ivany, and Kisha Supernant contributed.
- 3. On July 19, I experimented with the Edmonton Public Library's Lydia Zvyagintseva about historical content they could use to create user experiences with location-based beacons in libraries.
- 4. On July 20, I met Shawn Tse and Lan Chan-Marples to discuss a Chinese community art project showcasing the history and cultural impacts of Edmonton's Chinatown across the last century and a half. This project will conduct a research study around Chinatown life to produce five "figures" of artwork, including four Chinese ink paintings and one documentary film. We are applying for an EHC Living Local grant to make the project happen. If it goes ahead, I'll be supervising four Community Service-Learning students from the University of Alberta at CJSR, who will do some of the research that feeds into the artist's work. These students will also produce short audio segments about what they learned.
- 5. Postmedia reporter Mitch Goldenberg interviewed me for a July 23 Edmonton Sun/Journal article about the Rossdale Power Plant appearing as the default image for Edmonton when most people Google the city's name: <u>http://www.edmontonsun.com/2017/07/23/ok-google-its-time-to-change-edmontons-display-picture</u>
- 6. On July's episode of Let's Find Out, Samantha Power and I helped Kory deGroot find out where to learn about Edmonton's queer history.
- 7. I was interviewed by Metro national reporter Vicky Mochama for an August 9 article about how Chinatowns in Canada are changing over time: http://www.metronews.ca/views/metro-views/2017/08/09/an-lrt-runs-through-it-when-city-growth-leaves-chinatown-behind.html
- 8. I attended the Treaty Six recognition ceremonies at City Hall on Friday, August 18.

- 9. On August 23, I delivered a talk entitled "Yes, the Klan Had a Newspaper Here" for the Ignite Change Conference hosted by the John Humphrey Centre for Peace and Human Rights.
- 10. On August's episode of Let's Find Out, we are helping Tess Dehoog find out whether Nazi scientists ever visited Alberta to learn about our eugenics program.
- 11. Several Edmontonians and media outlets have reached out to me for help figuring out whether Edmonton has monuments, statues, or parks dedicated to white supremacist figures from our own past. The cloud of Charlottesville is hanging heavy here.

Coming Up

- We're working on a Let's Find Out episode about how the Papaschase First Nation lost their land.
- I'm meeting Karen Unland soon from the Alberta Podcast Network to discuss possibly integrating Let's Find Out into the network.
