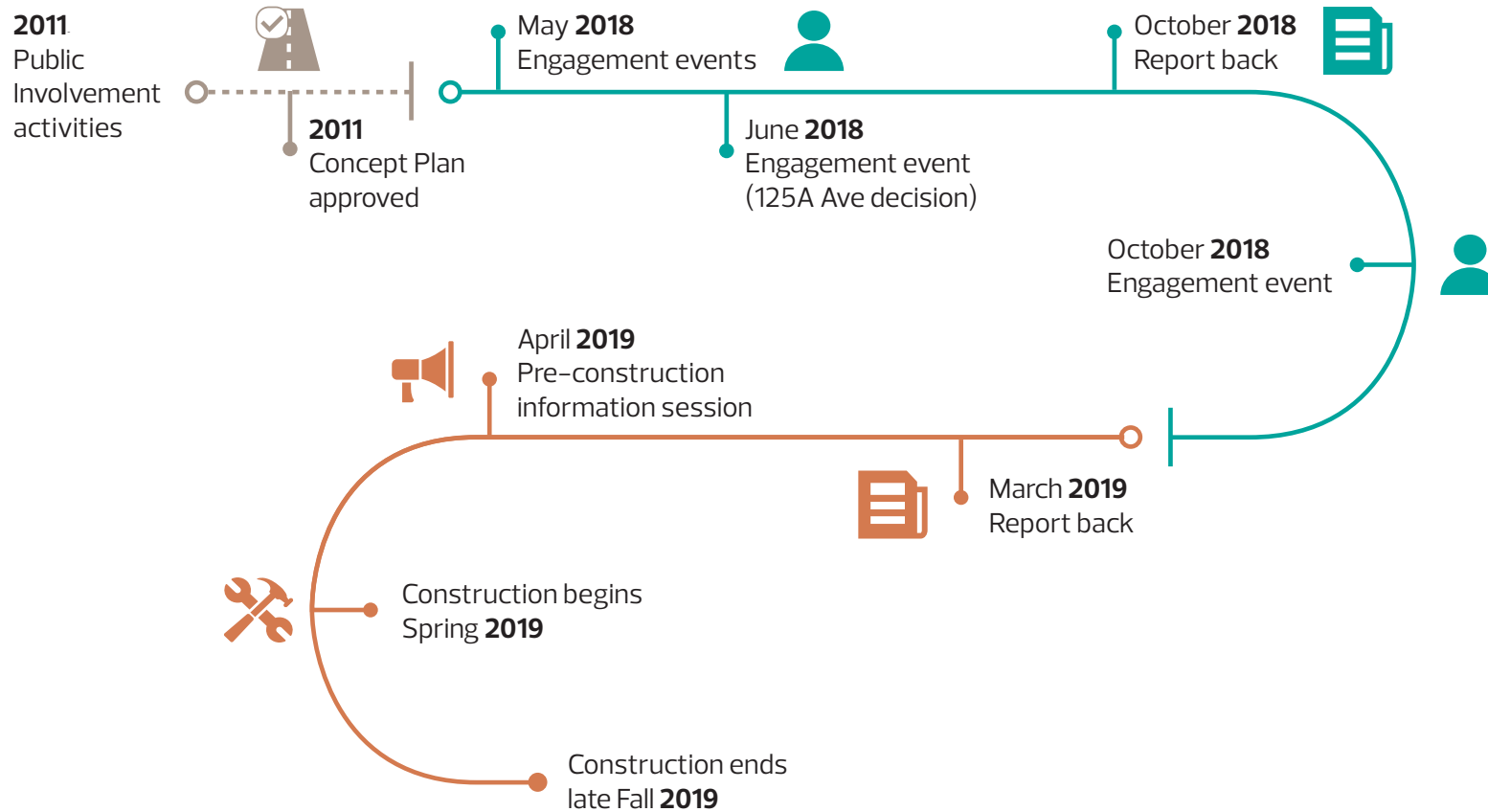
Project Scope



-  89 Street traffic signals on Yellowhead Trail will be removed
-  Direct access between 89 Street and Yellowhead Trail will be closed
-  Road changes to accommodate large vehicles
-  Sidewalk will be added along 125A Avenue from 97 Street to 82 Street
-  On-street parking along 125A Avenue will be removed
-  Addition of a second west bound lane across 82 Street

2019 Construction Information



Construction is estimated to begin in May 2019 and finish in October 2019.



One lane of travel will be open during construction.



Access to businesses will be maintained during construction.



All improvements within Delton Business Area will be completed before access to 89 Street is closed.

Communications During Construction



Area residents and businesses will be notified by the contractor within 10 days before construction begins and 5 days before any planned road or lane closures.



Construction bulletins will be issued 48 hours prior to any changes to accesses.



Construction information will be shared through construction bulletins, the pre-construction information session, road signs, our email list, project web page and social media.
